

SPECIFICATIONS

TRANSPORTATION AND DISPOSAL OF LEACHATE

This bid is designed to cover the removal, transportation and disposal of ashfill leachate from 1) the old Northern U Leachate storage tanks and 2) the Southern Storage tanks on Gleam Street.

The bid shall be for a one year period with two subsequent annual renewals subject to the approval of the Town of Babylon.

Prospective bidders shall understand that two separate price quotes are being solicited in this bid. The first bid item (#1), reflects the removal of leachate annually from the Northern ashfill on Patton Avenue in West Babylon. The second bid item (#2), reflects the removal of ashfill leachate from the two, 425,000 gallon above ground Southern Storage Tanks on Gleam Street, West Babylon. Item two will only be utilized during periods of pump station maintenance.

The bid is also requesting a price for a vacuum truck standby. This item is intended to utilize a vacuum truck in order to evacuate leachate transfer sumps during pump replacement by others. Truck will be dumped in the towns ashfill.

The Town makes no representation as to the amount of leachate to be pumped and disposed of.

The Contractor is expected to obtain and maintain required Town of Babylon, Suffolk County and New York State permits, including a New York State Department of Environmental Conservation ("NYSDEC") NYCRR Part 364 Permit.

New York State laws regarding the payment of prevailing wages applies to all employees who work under the auspices of this bid. **Certified payrolls must be submitted with each request for payment.**

The Town reserves the right to cancel this contract should NYSDEC or Suffolk County change their operational procedures or requirements.

The driver shall record the following on the Contractors Work Order Ticket:

1. Covanta scale ticket number
2. Truck Number
3. Truck capacity in gallons
4. The time the load was pulled
5. The tank the load was pulled from
6. The Clear Flo Technologies Inc. Manifest Number

This bid includes the transportation of leachate from the leachate storage tanks at the Town Solid Waste Management Facilities (TOBSWMFs) located north of Edison Ave, in West Babylon to the Clear Flo Technologies Inc. facility, 1110A Rte 109, Lindenhurst,

N.Y. 11757. There are no disposal costs associated with this bid item to be assumed by the Contractor.

The Contractor shall be responsible for any fines, violations or costs imposed on the Town due to any actions of the Contractor, including any increased costs associated with loss or suspension of any permits associated with leachate disposal. Said amounts to be deducted from outstanding invoices/accounts payable, if they should exist at the time said cost are incurred by the Town.

The truck must have a minimum capacity of 5,000 gallons and provide a vacuum pump capable of pumping to 15 foot depths. Proposer must demonstrate that drivers have the required New York State Department of Motor Vehicle Class III (CDL) license and vehicle liability insurance as per the attached schedule. Contractor will be required to submit a Certificate of Insurance from their agent. All trucks are required to have sight gauges to verify tank quantities.

It is the Town's intention to utilize the Clear Flo Technologies facility as the primary method of leachate disposal. The Contractor/leachate transporter will be required to complete any and all forms provided by the Town to allow for accurate record keeping. The Contractor shall provide a ticket for each load removed.

In the event the Clear Flo Technologies Facility is unable to accept Leachate, the bidders will provide an alternate price per 1,000 gallons to pump, transport and dispose of leachate at Bergen Point. This price shall include all costs including disposal fee at Bergen Point.

The Contractor shall weigh the empty truck upon arrival and each load removed, at the Town's scale.

Additional trucks may be needed at the direction of the Town of Babylon. These trucks must be provided within 24 hours of the Town's request. The Contractor must provide documentation that additional trucks can be provided to the Town if needed.

If the Contractor fails to provide service at any time, and/or can not provide additional trucks within 24 hours of the Town's request, the Town may hire another qualified company and the contractor shall pay the difference between the bid price and the additional cost to the Town.

When notified, the contractor shall provide service on Saturday as directed by the Town.

The Contractor shall be responsible for all clean-up or damage caused by spillage, leakage, etc. of leachate during the transportation and disposal required pursuant to this contract.

ALL FREIGHT CHARGES ARE TO BE INCLUDED. ANY BIDDER CHARGING FREIGHT MAY BE DISQUALIFIED.

NO MINIMUM REQUIREMENTS FOR DELIVERY. ANY BIDDER SETTING MINIMUMS MAY BE DISQUALIFIED.

Any bidder found imbalancing the bid in any of the unit prices will be cause for bid rejection.

The Town may award this bid in whole or in parts, or make no award at all, whichever is in the best interest of the Town. Bid awards are contingent upon available funding and the Town makes no guarantee that they will utilize all items on the bid.

All signatures to be original. Do not remove any pages from the bid contract. Return the bid contract in its entirety.

In addition, the successful bidder must comply with all current requirements of the New York State Department of Labor including, but not limited to, the payment of prevailing wages. Failure to comply will be the cause for the payment to be withheld.

Successful bidder must submit original certified payrolls with each request for payment. Failure to do so will result in payment being withheld.
